THAT, WHEREAS, there was recorded on March 1, 1972, as Document No. 3250, Official Records, in the office of the County Recorder of Los Angeles County, California, a counterpart of a certain agreement entitled "Unit Agreement, Signal Hill West Unit, Long Beach Field, Los Angeles County, California" dated December 1, 1971, executed by TEXACO Inc., and covering certain real property in the Cities of Signal Hill and Long Beach, said County and State, specifically described therein;

This agreement shall be binding upon the heirs, devisees, administrators, executors, successors and assigns of the undersigned.

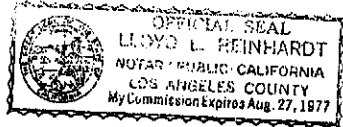
