ONE-HALF (1/2) thereof to Kip Kaler, as Bankruptcy Trustee of the Bankruptcy Estate of DeAnn Lian.



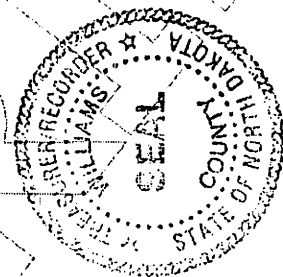
