Upon the Motion to Compel Turnover filed by Jill H. Ford, Trustee ("Trustee Ford") and after notice and opportunity for response and no response having been filed and good cause appearing therefor, the Trustee's Motion to Compel Turnover ("Motion") is hereby granted.

ACCORDINGLY,

IT IS HEREBY ORDERED, directing the Debtor to turnover to Trustee Ford the 2003 Dodge Neon VIN# 1B3ES56C93D100255, within fourteen days of the date of this Order.

IT IS FURTHER ORDERED directing the Debtor to turnover to Trustee Ford the 2001 Ford Mustang VIN# 1FAFP40421F255088, within fourteen days of the date of this Order.

IT IS FURTHER ORDERED directing the Debtor to turnover to Trustee Ford the 2000 Dodge Dakota VIN# 1B7GL22N9YS725932 (misidentified in Debtor's Schedules and in the Trustee's Motion as 2001 Dodge Dakota), within fourteen days of the date of this Order.

IT IS FURTHER ORDERED directing the Debtor to turnover to Trustee Ford the 1995 Dodge Dakota VIN# 1B7FL26G3SW909898, within fourteen days of the date of this Order.

IT IS FURTHER ORDERED directing the Debtor to turnover to Trustee Ford the 1990

1 Honda Accord VIN# JHMCB7657LC141295 (misidentified in Debtor's Schedules and in the Trustee's
2 Motion as 1994 Honda), within fourteen days of the date of this Order.

3 **IT IS FURTHER ORDERED** in the event Debtor fails to turn over the above referenced non-
4 exempt vehicles within fourteen days of the date this Order, directing the Debtor to turnover the
5 amount of **\$9,029.00** constituting the equivalent value of the non-exempt vehicles.

7 **IT IS FURTHER ORDERED** if Debtor fails to turn over the non-exempt vehicles within
8 fourteen days of the date this Order, that Trustee is awarded **\$750.00** in reasonable attorney's fees and
9 costs, and directing Debtor to remit payment of the sum of **\$750.00**.

10 **IT IS FURTHER ORDERED** that interest on the amount due, until paid, shall accrue at the rate
11 set forth in 28 U.S.C. §1961.

IT IS FURTHER ORDERED that the lien against nonexempt earnings of the Judgment Debtor shall continue until the full judgment of \$9,779.00 plus interest at the rate set forth in 28 U.S.C. §1961 per annum is satisfied in full.
