motion and all responses on file, the Court finds that Debtors/Defendants' answers and

responses should be compelled in part.

IT IS ORDERED THAT Plaintiffs' Joint Motion to Compel Defendants' Answers to

Interrogatories and Responses to Request for Production is GRANTED as follows:

Debtors/Defendants shall provide a complete Answer to Interrogatory #4 without

referring to the Monthly Operating Reports in their Answer;

Debtors/Defendants shall provide all records responsive to Request for Production #9;

Debtors/Defendants shall amend their response to Interrogatory #5 to identify the specific Order(s) upon which Debtors/Defendants relied, if any;

Debtors/Defendants shall amend their response to Interrogatory #13 to identify the specific Order(s) upon which Debtors/Defendants relied, if any;

Debtors/Defendants shall provide a complete Answer to Interrogatory #14 without referring to the Monthly Operating Reports in their Answer;

Debtors/Defendants shall provide all records responsive to Request for Production #15; and

Debtors/Defendants shall provide all records of bank accounts for the Law Office of Mark Cantu responsive to Request for Production #22.

IT IS FURTHER ORDERED THAT rulings on Requests for Production #19, #31 and #32 are under advisement with the Court.

IT IS FURTHER ORDERED THAT the answers and responses ordered herein shall be provided to Plaintiffs no later than Monday, August 2, 2010.

IT IS FURTHER ORDERED THAT Plaintiffs may amend their trial Exhibit List to include any amended/supplemental Answers or documents produced pursuant to this Order within five (5) days of Defendants'/Debtors' production.
