**AMENDED DEFAULT JUDGMENT**

The matter before the Court in this adversary proceeding case is the motion filed by the Plaintiff, John Paul H. Cournoyer, Chapter 7 Trustee for North Carolina Tobacco International, LLC pursuant to Federal Rule of Civil Procedure 55 and Bankruptcy Rule 7055, for judgment by default. A hearing was held at the United States Bankruptcy Court in Greensboro, North Carolina on October 22, 2019; Stephanie L. Osborne appeared on behalf of the Plaintiff/Trustee, but no one appeared on behalf of the Defendant. For the reasons that follow the Plaintiff's motion for Default Judgment is **GRANTED**.

1. Defendant has failed to plead or appear or are otherwise subject to default judgment as provided by the Bankruptcy Code and Federal Rules of Civil Procedure and as shown by the Affidavit attached to the Plaintiff's motion.
2. On March 25, 2019, the Clerk entered a default in this adversary proceeding.
3. The Plaintiff seeks to recover from the Defendant the sum of \$231,319.16, plus interest at the legal rate from October 5, 2018, the date of the filed complaint.
4. The Court finds that cause exists to enter a Default Judgment in favor of the Plaintiff.
5. This Amended Default Judgment is entered to correct the amount of the judgment due the Plaintiff.

Accordingly, it is hereby **ORDERED, DECREED and ADJUDGED** that a judgment is entered against Tobacco Solutions Asia, Ltd., and in favor of the Plaintiff in the amount of \$231,319.16, plus interest at the legal rate from October 5, 2018.
