ORDERED AS FOLLOWS:

1. Judgment shall be and hereby entered in favor of Plaintiff and against Defendant RATERIA EXPORTS on Count One (11 U.S.C. § 547) and Count Six (11 U.S.C. § 550) of the Complaint in the amount of \$34,156.80
